MINUTES OF THE BOROUGH OF CLEMENTON JANUARY 6, 2018 ANNUAL REORGANIZATION MEETING OF THE MAYOR AND COUNCIL

OPENING: Mayor Weaver called the meeting to order at 11:05AM
