MINUTES OF THE BOROUGH OF CLEMENTON JANUARY 7, 2017 ANNUAL REORGANIZATION MEETING OF THE MAYOR AND COUNCIL

OPENING: Mayor Thomas Weaver called the meeting to order at 11:01AM.

OATHS ADMINISTERED TO NEWLY ELECTED OFFICIALS:

SWEARING IN OF JONATHAN FISHER TO THE OFFICE OF COUNCILMAN IN THE BOROUGH OF CLEMENTON FOR A TERM OF THREE YEARS- Mayor Weaver administered the oath of office to Jonathan Fisher for the office of Councilman for a term of three years, while his grandson held the bible.

SWEARING IN OF THOMAS SHAW TO THE OFFICE OF COUNCILMAN IN THE BOROUGH OF CLEMENTON FOR A TERM OF THREE YEARS- Councilwoman Nucera administered the oath office to Thomas Shaw for the office of Councilman in the Borough of Clementon for a term of three years, while his family looked on and his daughter held the bible.

INTRODUCTION OF DIGNITARIES: It was noted that Freeholder Gabrielle Mosquera had been in attendance but departed prior to the opening of the meeting due to the inclement weather. Mayor Weaver also acknowledged that Mayor Richard Roach of Lindenwold was in attendance.

Mayor Weaver invited the newly elected members of council to speak.
