# MINUTES OF THE BOROUGH OF CLEMENTON NOVEMBER 22, 2022 7:00PM CAUCUS/COUNCIL OF THE MAYOR AND COUNCIL

**OPENING:** Mayor Thomas J. Weaver called the meeting to order at 7:02PM.

RESOLUTION R22-195 AUTHORIZING THE MAYOR AND MUNICIPAL ADMINISTRATOR TO EXECUTE NEW JERSEY DEP FORMS TWA-1 AND WQM-003 RELATING TO APPLICATION FOR APPROVAL OF A COMPREHENSIVE SEWERAGE COLLECTION SYSTEM AND/OR WATER DISTRIBUTION SYSTEM WHICH HAS BEEN GRANTED FINAL APPROVAL BY THE MAYOR AND COUNCIL AS TO LEEWOOD VILLAGE, PHASE III & IV. Mayor Weaver read by title. Councilman McKelvey motioned to approve. Councilman Shaw seconded the motion and it was carried upon the call of roll. Ayes: Cantwell; Dorsey; Franks; McKelvey; Shaw. ### **NEW BUSINESS:**

ESTABLISHMENT OF ANNUAL REORGANIZATION MEETING DATE- TUESDAY, JANUARY 3, 2022 AT 7PM. Brief discussion occurred and it was confirmed that the annual reorganization meeting would be held in the court room at Boro Hall on the above date indicated.

MAYORAL APPOINTMENTS TO SHADE TREE COMMISSION- Mayor Weaver announced that the following mayoral appointments were to become effective immediately:

Councilman Dorsey stated that the Fire Academy at Camden County College was interested in purchasing the backhoe, as indicated previously, in the amount of \$15,000. The agreement included a monetary payment of \$10,000, and \$5,000 training credits for Clementon Fire Rescue. Councilman Dorsey noted that research had been completed on the fair market value, which matched the \$15,000 total purchase price. Solicitor Botcheos stated that this information was sufficient and the private sale to Camden County College was allowable.

Councilman Dorsey motioned to approve the sale of surplus equipment no longer utilized by the Borough of Clementon, specifically the Backhoe. Motion was seconded by Councilwoman Franks and carried upon the call of roll. Ayes: Cantwell; Dorsey; Franks; McKelvey; Shaw. Absent: Strobl. (Memorialized by Resolution R22-196)

Councilman McKelvey suggested that the vehicles that are valued less than \$5,000 and not in use be transferred for extrication training use to the Clementon Fire Rescue. After brief discussion, it was noted that Robert Freiling would supply the VIN numbers for the specific vehicles and confirm their value. A resolution would be forthcoming at a meeting when all of the necessary information was provided.

Councilwoman Franks stated that she would like to introduce a TNR Ordinance in Clementon Borough to address the growing feral cat population, and allow for potential funding of the program.

Councilwoman Cantwell reminded everyone that the Holiday Parade was being held on December 9<sup>th</sup>, and encouraged attendance.

Councilman Shaw stated that he would be bringing forth a request from the Police Chief for the potential promotion of a Sergeant in 2023.

Councilman Dorsey reported that the change order and agreement with the solid waste collection company had not gone through with the new owner. It was noted that new recycling cans would need to be purchased by the municipality, and the Public Works Director, Kevin Garretson, would be incorporating funding into his 2023 budget request for this purpose. Mark Basehore of Bach Associates stated that his firm was looking into how many additional units would need to be supplied cans with the new developments.

## **UNFINISHED BUSINESS:**

There were no discussions for unfinished business.

**PRIVILEGE OF THE FLOOR:** Mayor Weaver opened the floor to the public.

John Schmidt, Chairman Clementon Housing Authority- Mr. Schmidt stated that he wished to schedule a meeting with the Governing Body and Clementon Housing Authority relating to potential repositioning occurring at the CHA. Mr. Schmidt stated that the intent would be to keep existing Borough agreements the same. It was determined that a Council Committee would meet with the Clementon Housing Authority at a date to be determined.

**ADJOURNMENT:** Councilman Shaw motioned to adjourn at 7:53PM. Motion was seconded by Councilwoman Franks and hearing none opposed, meeting was adjourned.
