MINUTES OF THE BOROUGH OF CLEMENTON DECEMBER 13, 2022 7:00PM CAUCUS/COUNCIL OF THE MAYOR AND COUNCIL

OPENING: Council President Thomas Shaw called the meeting to order at 7:00PM.

SALUTE TO THE FLAG: Council President Shaw led in the salute to the flag.

PRIVILEGE OF THE FLOOR FOR A TOTAL TIME NOT TO EXCEED 10 MINUTES FOR ITEMS APPEARING ON THE AGENDA ONLY: Council President Shaw opened the floor to the public for matters appearing on the agenda. Hearing no comments from the public, the floor was closed.

NEW BUSINESS:

MAYORAL APPOINTMENT OEM COORDINATOR- Jenai Johnson stated that she had been provided a letter from Mayor Weaver, indicating that he was appointing Leah Freiling to the office of Emergency Management Coordinator, effective immediately. Jenai Johnson noted that the appointment was necessary due to the retirement of Adrianne Guernon, who formerly held the title.

UNFINISHED BUSINESS:

Councilwoman Strobl reported that she had been working with the library on multiple tasks, and would keep everyone abreast of the progress.

Councilwoman Franks thanked everyone for their hard work on the parade, tree lighting and decorations. Councilwoman Franks noted that she felt that the decorations were greatly improved this season.

Councilman McKelvey stated that he had been advised that the town improved in literacy points since the Camden County Literary Committee had become involved. Brief discussion occurred regarding the possibility of obtaining additional funding for the library from Camden County, and it was determined that Councilwoman Strobl would contact the library system to further investigate.

PRIVILEGE OF THE FLOOR:

Council President Shaw opened the floor to the public.

Gina Vallente, 51 Highland Ave- Ms. Vallente stated that she was in attendance to see what could be done, or who could help with an issue she was having with a neighbor and shed, which she believed required a variance. Ms. Vallente noted that the yard was not in good order with construction debris strewn about. Jonathan Holroyd, Code Enforcement/Zoning Officer, reported that the shed was being moved at the direction of the municipality, and he would address the trash in the yard.

John Schmidt, Clementon Housing Authority- Mr. Schmidt provided a summary financial sheet from the Clementon Housing Authority, and noted that a meeting would be rescheduled with the council committee and Housing Authority.

Hearing no further parties interested in speaking, the floor was closed.
