League advertisement for a permanent part-time position.

Brenda Franks: Planning and Zoning Currently requires Background Checks for all Mercantile. Franks feels we should only be requiring this for Auto Dealers, Medical facilities and daycares. Solicitor states this can be waived by Council. Council will need to decide.

Gwen Cantwell: Had a resident ask if the Minutes are on the website. Website is being looked at for issues.

Community Center Rates and New Policies: Committee (McKelvey, Cantwell, Weaver) needs to reconvene to decide rates, costs and needs.

**PRIVILEGE OF THE FLOOR:** Mr. Venuti: 2 Grove Ave. Complaint of ongoing problem with ATVs. Solicitor to check into code for ATVs. Will provide ordinance or enhanced ordinance.
