Councilwoman Gwen Cantwell brought a concern from the public about whether the swing will be replaced at Niagra Park. The swing was damaged over year ago, removed and never replaced. Robert Freiling from Public Works will check into replacing the swing.

Robert Freiling was asked to send a complete list of products for sale at the Public Works Garage in order to form a Resolution to approve the sale of these items at the next meeting.

PRIVILEGE OF THE FLOOR:

Alesha Rimby & Donna Rimby – 251 White Horse Ave, Clementon Ms. Rimby and Ms. Rimby read a letter to the Mayor and Council on behalf of Library Trustees concerning the Library Book Sale which recently took place. Councilwoman Cantwell spoke with them and agreed that there will be a separate meeting scheduled to address these matters between Councilwoman Cantwell, Councilwoman Strobl, the Mayor and The Library Trustees Committee.

Sherry Tribble, Mike Gillespie (Eatery Association)- Essie's Café Garfield Ave- Essie's would like to host a block party to celebrate the one-year anniversary of the store on Saturday June 24th and asked for the town's approval to close off Garfield Ave. Mayor Weaver has contacted the county about stage on their behalf and family friendly entertainment is permitted. No alcohol is to be served outside. No objections were noted.
