NOTICE OF TAX SALE
SALE OF REAL PROPERTY FOR UNPAID TAXES AND MUNICIPAL LIENS

Public notice is hereby given that I, Jo Ann Watson, Tax Collector for the Borough of Clementon, County of Camden, State of New Jersey, will sell at public auction at the **Clementon Municipal Building, 101 Gibbsboro Road, Clementon, New Jersey** on **Thursday October 8, 2026 at 10:00 a.m.**, the following lots, parcels and tracts of land for the amount of Taxes, Water, and Sewerage and C.C.M.U.A. and other Municipal charges that remain unpaid for the year 2025 and prior years together with interest and cost computed to the date of the sale. Such sale shall be made in fee to such person that will purchase same, subject to redemption at the lowest rate of interest, but in no case to exceed 18 per centum per annum.

Payment shall be made in full before the conclusion of the sale or the property will be resold.

Cash or Certified check only will be accepted as payment on the day of the sale. Any parcel for which there is no bidder will be struck off to the Municipality at 18 per centum per annum.

Payment of the amount due may be made on any parcel prior to the sale by Cash, Certified Check, whereupon, the impending sale will be cancelled.

Industrial Properties may be subject to the Spill Compensation and Control Act (N.J.S.A.58:10-23 et seq.), the Water Pollution Control Act (N.J.S.A. 58:10A-1 et seq), and the Industrial Site recovery Act (N.J.S.A. 13:1K-6 et seq.). In addition, the Municipality is precluded from issuing a tax sale certificate to any prospective purchaser who is or may be in any way connected to the prior owner or operator of the site.

This sale is made under the provision of the Tax Sale Law, Title 54, Chapter 5, revised Statutes of the State of New Jersey.
